*In order to fully complete the online Code of Ethics class, applicants must finish the online class and pass the exam before the 90 day deadline.*

Both online and classroom Code of Ethics sessions meet the National Association of REALTORS® (NAR) mandatory two-year ethics training requirement. Classes taken in 2018 meet the requirement for the 5th cycle, which began 1/1/17 and ends 12/31/18. Classes taken in 2019 meet the requirement for the 6th cycle, which begins 1/1/19 and ends 12/31/20.

## Registration:

## Location:

No CE for Orientation or online Code of Ethics.

If an applicant fails to complete both new member requirements within 90 days and is not granted an extension, the application becomes void, forfeiting both the application and the application fee. The applicant must then reapply and pay another \$200 non-refundable application fee.
