Both online and classroom Code of Ethics sessions meet the National Association of REALTORS® (NAR) mandatory two-year ethics training requirement for the 6th cycle, which began 1/1/19 and ends 12/31/20.

Location:

CE:

If an applicant fails to complete both new member requirements within 90 days and is not granted an extension, the application becomes void, forfeiting both the application and the application fee. The applicant must then reapply and pay another \$200 non-refundable application fee.
